PRIVILEGE LICENSE

GENERAL INFORMATION & RATE SCHEDULE

Privilege License taxes are required to be paid before beginning operation of all types of businesses located within the City limits of Archdale, except for those businesses who have been exempted by Federal, State or Local authority. Those businesses located outside the City that are doing business within the City limits are also required to obtain a Privilege License.

Please fill out the enclosed application making sure to **check** all categories that apply to your business. An authorized representative of the business must sign and date the application. Incomplete applications will not be accepted.

Privilege License fee for 'Schedule A General Business' is a combination of flat rate and gross sales/receipts. Record gross sales/receipts for your last completed fiscal year (12-month period) if they are greater than \$1,000,000. New businesses must estimate gross sales/receipts for the period remaining in the current license year. The rates are as follows:

Estimated Annual Gross Sales not exceeding \$1,000,000.00 = \$50.00
Each additional \$1,000 or fraction thereof = \$.50

EXAMPLE: Gross Sales	=	\$1,001,150.00
Flat Rate for \$1,000,000	=	50.00
\$2,000 @ .50 per \$1,000	=	1.00
TOTAL AMOUNT DUE	=	\$ 51.00

The business activities listed on Schedule B are determined by State Statute. These categories are still charged at a flat rate (see attached list). **Exclude any income from business activities taxed under Schedule B & C.** For example: any money made from the sale of beer, wine, ice cream, cigarettes, etc. is to be deducted from the gross sales/receipts and the remaining balance is to be reported and the appropriate fee paid.

Owners of Rental Properties (commercial and/or residential) are subject to a \$50 fee for 2-5 units plus \$10 for each additional unit. Management companies are subject to gross receipts made within the City limits.

In order to protect your privacy, the amount you pay for your license will not be printed on the face of the license.
